
Website Privacy Policy

This Website Privacy Statement applies to this website which is operated by Auyin Property Development Pty Ltd (ACN 119 204 232) (“Auyin Property Development”) under the domain name **www.auyindevelopment.com.au** ("the Website").

Information collected through the Website may be collected by any member of Auyin Property Development (referred to as "we", "us", "our") in accordance with this Website Privacy Statement. Auyin Property Development and entities controlled by its proprietors is committed to protecting the privacy and confidentiality of information collected through the Website and treats personal data with respect and integrity. Respect and integrity form part of our core values, which are the foundation for the conduct of the business. The Website Privacy Statement relates generally to the protection of personal data (being information which is capable of identifying an individual) and is applicable to the use of this Website.

We will post any changes to this Website Privacy Statement on the Website, so we encourage you to check this Website Privacy Statement from time to time. Any personal data collected under this current Website Privacy Statement will be handled in accordance with this Website Privacy Statement. After the changes take effect, all new personal data collected, if any, will be subject to the revised Website Privacy Statement.

Information collected

The personal data about you which this Website may collect includes:
